One of the things we discussed at our recent Board meeting in Macon was the impact of HIPAA on the Lighthouse, and how it impacts the type of information we can share with Lions and other groups. HIPAA is the patient privacy act that recently went into effect and its goal is to safeguard individually identifiable patient information. For the Lighthouse, this means that we cannot, by law, share information about anyone we serve. If, for example, a Lion refers someone to us for services, and then later calls to ask us about the status of the application, we cannot discuss it nor can we indicate if we have even received the application. Patients will need to contact the Lighthouse directly about the services they are applying for, rather than having other people call on their behalf. The Lighthouse will be seeking further clarification on HIPAA and will be sharing new information as we learn it.

Just a reminder that it is not too late to begin planning for White Cane! Many Clubs hold their White Cane events in April, but clubs can hold these events at anytime of the year. All funds raised for White Cane go directly to sight services. We will be making some changes to the White Cane booklet this year, based upon your suggestions, and will be making it available to clubs earlier. Our goal for White Cane is \$175,000. Please help us reach our goal this year!

Better Hearing Month is coming up in March. You will be receiving information in January about hearing loss, ways to help educate your community about how to safe guard hearing, Public Service Announcements and other information to help you educate your community about hearing loss. Please join us in this important public service!
